We use your personal information only for the purpose for which it is collected. This purpose could include providing a service, assisting us with administration, recruiting prospective employees, or complying with a legal





obligation. We may also use your personal information for similar purposes  $e^{S_0 \log 48781}_{\text{Not}}$  including marketing and communications, but that will only occur if we have your consent or another lawful justification for doing so.

We may share your information with third-party service providers to fulfil our agreed contract, including those that operate outside of the borders of South Africa. In these cases, we will ensure that these operators meet the same duty of confidentiality that we do.

## 4 What personal information do we collect?

We only collect the minimum amount of information that is relevant to the purpose. If you interact with us on the internet, the personal information we collect depends on whether you just visit our website or, use our services. If you visit our website, your browser transmits some data automatically, such as your browsing times, the data transmitted and your IP address.

If you use our services, personal information is required to fulfill the requirements of that service.

Generally, we collect the following personal information. If there is any *specific* personal information to collect, we will indicate as such, at or near the time of collection.

## 5 How do we look after personal information?

We limit the amount of personal information collected to only what is fit for the purposes as described above. We restrict, secure and control all of our information assets against unauthorised access, damage, loss or destruction; whether physical or electronic. We retain personal information



## 6 How can you access your personal information?
